

## HOOK PARISH COUNCIL – Questionnaire

**Redevelopment of the retail centre – some very rude remarks about Grand Parade**  
**Parking – a strong indication of concerns**  
**Traffic and the A30 – suggestions for the by- pass of traffic and pedestrian areas**  
**Busses and Public Transport improvements**  
**Cycle routes**  
**Open Space**

**The Parish Council has identified that 4 full size football pitches, 6 mini football pitches, and a cricket square with associated pavilion would be the minimum requirement to meet the current and future need. The pitches can be shared public open space available for football, not necessarily dedicated football pitches (as stated in Q3 above). The Parish Council also believe that a sum of money to improve the current Community Centre at Ravenscroft would be of benefit to the community (as stated in Q4 above).**

**There may be a requirement in the future for the Allotment Association to acquire additional land as a result of the development. The Parish Council propose to request a sum of money to be held in reserve for future use.**

**Provision of a safe crossing over the B3349 and the A30 together with measures to address traffic issues such as the congestion on the A30 at peak times would be fundamental to any development and needs to be addressed as part of the planning process.**

**Problems with the water supply have been identified in the Village and the Parish Council welcome the major off-site reinforcement works.**

**This is considered to be a crucial element to any development in this part of Hook and the Parish Council intend to insist that the works to replace the pumping station be commenced before any development takes place.**

**The proposal for a development site in North East Hook could only be effectively opposed if the Parish Council and residents could suggest sound reasons why this site is less suitable for development than other available sites in the District. Reasons that have already been addressed and discounted in the Core Strategy document will be disallowed by the District Council.**

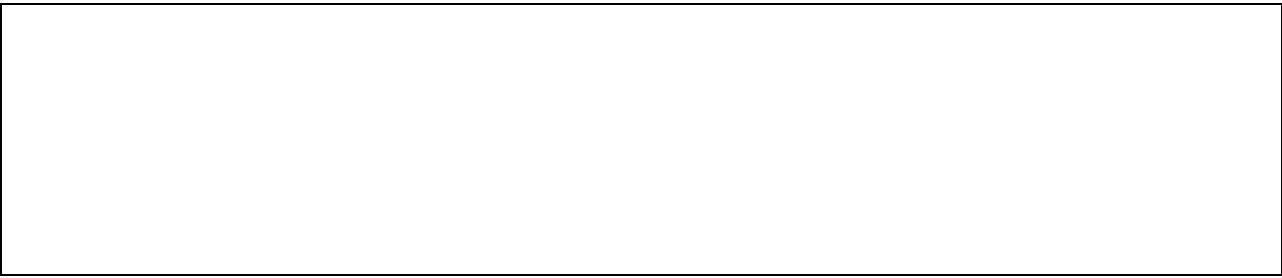
**Q14.** On this basis - and taking into consideration the facilities that could potentially be provided - do you think that Hook should support or oppose the proposed development?
